My name is Scott Zrubek and I am pleased to announce that I am back for another round as the Art Show director for ArmadilloCon 28. As has always been policy, I hope to make this show both pleasant and profitable for the participants and exhibitors. Enclosed in this packet is this letter, Art Show Rules and an Entry Form. This packet is also available at http://www.armadillocon.org/art.htm. Space is limited, so send in your forms as early as possible. First come, first served. There is no Print Shop this year.

Mailing Artwork

- Packages must be prepaid and be sure to include sufficient postage to cover return shipping and insurance (or let me know that you
 wish it to be paid from your sales.)
- · Utilize reusable cartons/packing material.
- Specify your return shipping service (UPS, Federal Express, USPS, etc.) and the exact amount of insurance, if any.
- If no special instructions are given, the art will be returned collect via UPS ground with no insurance.
- If you are mailing your art, we need to receive it by **Monday**, **August 8**, **2006**. If this is going to be a problem, please let me know. (This does not apply to those who will be bringing their artwork.)
- ArmadilloCon receives a 15% commission on artwork sold through the Art Show, including auction.
- Let me know if you have any special needs (electricity, free-standing artwork, etc.) and I will do everything I can to accommodate you; however, please be aware that our facilities are very limited.
- We will provide hanging hardware (hooks, clips, etc.)
- Panel fees are \$15 for a 4'x 4' panel, with a maximum of 3 panels (4' x 12') per artist.
- Tables are \$15 for a 6' table, \$10 for a ½ table, with a maximum of 2 tables per artist.

Costs

- All funds must be in US dollars drawn upon a US bank.
- Make checks and money orders payable to "ArmadilloCon 28."
- We can also take Visa, MasterCard, and American Express Cards.
- If we have vacancies, we will release the open panels/tables to all artists on July 7. Please be sure to mark on your entry form if you are interested in more than three panels/tables and I will contact you by e-mail if we have vacancies. Please be aware that over the past few years we have had a waiting list for space, so vacancies were scarce.

Rules

- 1) Art should be of a Fantasy, Horror (Dark Fantasy) or Sci-Fi theme. Single copies of signed limited-edition prints are allowed for bid sale as long as those same prints are not available elsewhere at the .
- 2) You may display an original with "NFS" (Not For Sale) on the bid sheet.
- 3) There will be no "resold" artwork allowed. All work must be the property of the artist or agent exhibiting at the show.
- 4) ArmadilloCon reserves the right to refuse the exhibition of any piece for any reason. Works that are judged to be libelous, plagiaristic, obscene, or detrimental to the value of trademarked characters will not be permitted. Likewise, no artwork from commercial patterns, kits or molds is permitted. If you have any questions, please contact me. If problems arise, you may be requested not to show a particular piece. (Very rarely do we ever have to invoke this rule.)
- 5) All two-dimensional artwork must be matted, shrunk-wrapped, mounted, and/or framed. When hanging, please allow enough room for bid sheets.
- 6) We recommend that small three-dimensional artwork (such as jewelry) be in a lockable, closed display case. Small items without a case should be securely fastened to a larger display board or device. ArmadilloCon is not responsible for theft or damage to small pieces displayed without these precautions.
- 7) All artwork must be clearly labeled. A bid sheet must be made out for all pieces, whether for sale or not. (Please print legibly on the bid sheets.) If you are mailing in your artwork, you may find it convenient to include a hanging diagram. Please allow room for your bid sheets and any other materials (business cards, etc.) you wish to display.
- 8) Once entered in the show, no piece may be withdrawn before 12:00 p.m. Sunday, nor may the conditions of sale amount of minimum bid, NFS status, Quick sale amount, etc.—be changed without the express approval of the Art Show Director.
- 9) Art will be accepted Friday, beginning at 9:00 am. A receipt will be issued for all art accepted. Artwork may not be reclaimed without this receipt and identification. If you cannot reclaim your art, please make prior arrangements with the Art Show Director.
- 10) Photography will not be allowed within the art show without the express permission of the Art Show Director. Please do not give anyone permission to take photos of your pieces in the art show. Press photographers may be allowed to take wide-angle shots of the room, or photograph a particular artist's panels with the artist present, but only with permission from the Art Show Director and the artist.
- 11) Minimum Bid is the least price you will accept for the sale of your art. The Quick Sale Price (if you elect to have one) should be a higher price that will enable the piece to be sold without going to auction. The Sunday price is the fee that you are willing to take if your piece hasn't sold by end of business on Saturday.
- 12) We will have an auction this year. All pieces that receive 3 or more bids will go to Auction. Price your artwork accordingly.

Print Shop

1) There is no Print Shop this year.

General Information

- 1) All pieces are sold without any reproduction rights. If you should wish to negotiate these rights, let us know and we will provide a list of pieces sold with the names and addresses of the purchasers.
- 2) Be prepared for the Art Show staff to handle your sold artwork. Please provide packing/carrying materials for 3D objects. (Plastic bags are acceptable for lightweight items that are unbreakable such as t-shirts, stuffed animals, etc.)
- 3) You do not have to be a member of ArmadilloCon 28 to exhibit in the Art Show. However, once the convention begins, artists do not get automatic entry into convention activities. If you or your agent is attending, please plan to pick up all artwork between the hours of 12:00 and 2:00 pm Sunday.
- 4) Artists do not get a free membership to ArmadilloCon unless they have an agreement with Programming.
- 5) The Art Show is locked every night and a representative from the Art Show is in the room at all times while the Art Show is open.
- 6) The PDF forms online are interactive. You can fill them out electronically and save them to your computer as well as send them to me in electronic format. This is easiest for all of us, so please take advantage of this eco-friendly method. However, if you wish to print your forms and mail them to me, that is fine as well.
